#### VI. **EQUALIZATION FUNDING FORMULA**

Ron Bennett, Chief Executive Officer of School Services of California, attended the meeting for one hour to present the School Services Equalized Funding Model report to the Governing Board. Mr. Bennett provided a history of Metropolitan Education District, reviewed salary schedules from other districts, and supplied information about charter schools. He completed the review by clarifying the funding options and different methodologies that the JPA Superintendents could discuss based on the charts he created, which exemplified equalizing the costs of sending students to Silicon Valley CTE Center. Mr. Bennett allocated time for questions from the Board Members.

#### VII. MARKETING PLAN FOR METROED

Dan Orloff, President of Orloff Williams Full Service Marketing Communications, provided a 30-minute presentation on the marketing research conducted by Orloff Williams to create a new tagline for Silicon Valley CTE (SVCTE). Using a PowerPoint presentation, Mr. Orloff shared samples of the new SVCTE business cards, email signatures, future websites, and a brochure for SVCTE. Mr. Orloff indicated that upon completing work for SVCTE, he would update materials for Metropolitan Education District and Silicon Valley Adult Education.

# VIII. ACTION ITEM: AGREEMENT WITH INDEPENDENT CONTRACTOR, RHONDA FARBER: \$5,000

<u>Vice President Dean</u>: He said he would support the agreement with Independent Contractor, Rhonda Farber, if it was brought back for discussion. He said he had made his comments in Closed Session on June 25, and Superintendent Lynch has had time to consider his feedback. He said Superintendent Lynch feels Ms. Farber is the appropriate coach to hire.

<u>President Bobay</u>: He asked Vice President Dean if he felt Ms. Farber was still not an appropriate choice.

<u>Vice President Dean</u>: He said because he is not the recipient of Ms. Farber's coaching, only Superintendent Lynch may guide her in the areas of which she requires to be coached with input from the Board President. He said he determines his decisions or recommendations on whether he has confidence in the subject or does not have confidence in it. He said Ms. Farber is very intelligent and a hard worker.

Member Garcia: He said the Board was aware of Vice President Dean's concerns; he wanted assurance that Superintendent Lynch and Ms. Farber were aware of Vice President Dean's concerns.

Superintendent Lynch: She affirmed that she and Ms. Farber are aware of Vice President Dean's concerns.
